Calls for Service

With the warmer weather, our calls for service in April have increased. We responded to 120 calls for service, including 6 requests for mutual aid. Comparing this years past, our calls for service are up (32% from 91 last year and 82% from 66 in 2017). Our Traffic and Criminal calls are down this year from last year (Traffic down 18%/Criminal down 67%) while Service calls are up 214%, General calls are up 40%, and Ordinance calls are up 257%. Our CSO took care of 7 of the Ordinance calls, in addition to 9 citizen contacts and issuing 5 building permits. We issued 7 traffic citations and 4 ordinance citations to municipal court. We made one misdemeanor arrest and one felony arrest.

Our year to date numbers reflect similar trends as the monthly. Traffic calls are down 33% and Criminal calls are down 15%. Service calls are up 274%, General calls are up 14%, and Ordinance calls are up 55%. Our total calls for service are up 29% this year from last (458 calls from 355 last year) and 48% from 2017 (309 calls). The Dunn County Sheriff's Office responded to an additional 16 calls for service in the village while our officers were not available.

Budget

We are a third of the way through the budget year and are on target. The new CAD/RMS software is still on target to go live later this year.

Other Activities

We received the grant last week to purchase the new AEDs. We will order these soon and install them in each squad and Village Hall. We've been asked to participate this summer in a traffic safety grant with the Dunn County Sheriff's Office. We were deploy officers on extra shifts that will be reimbursed by the State. We completed our required training for the State and will be submitting our request for reimbursement.

We've continued to be present at the various community and sporting events in addition to random patrols through the schools. We made a presentation at Boyceville Middle School for career day. We worked together with Boyceville EMS and Fire Department to present a mock car crash before prom, which was well received. Prom went off without any hitches. We hosted a mock drug room and a drug take back. We gathered 18 pounds of unwanted medications for destruction. We also just received a permanent drop box via a grant that the Dunn County Partnership for Youth obtained on our behalf.

We've continued to meet with the school administration about SROs, or Youth Services as we've decided to call it to cover all of the duties we and the school would like the position to cover. We've also prepared a preliminary budget to help the school with discussion and prepared job descriptions for all police employees for you to review tonight. As a part of this, we've made long term organization plans.

Officer Kurtzhals was sworn in and has been working some training shifts to familiarize him with the Village. We will have two officers on duty to monitor graduation.
